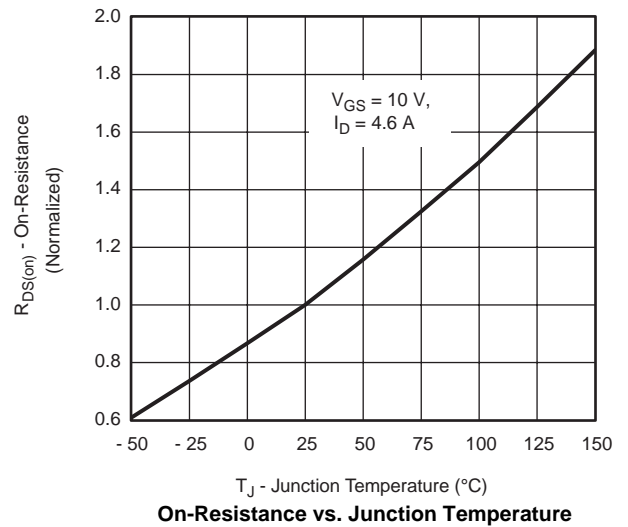
On-Resistance vs. Drain Current

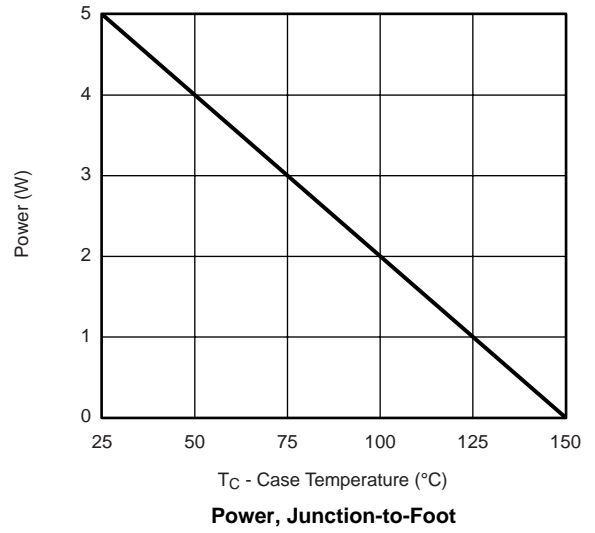
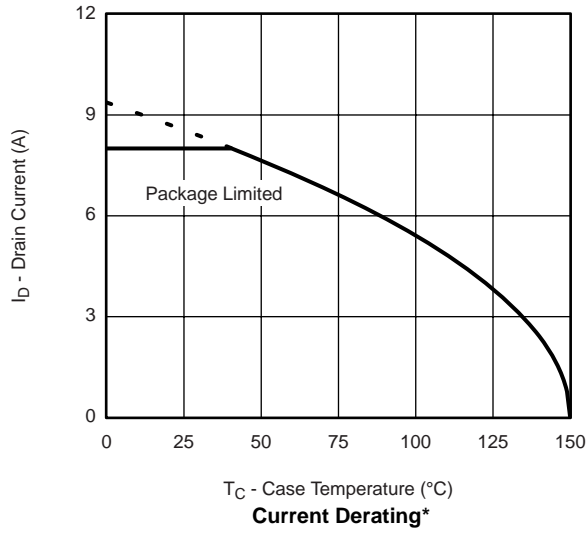


On-Resistance vs. Junction Temperature

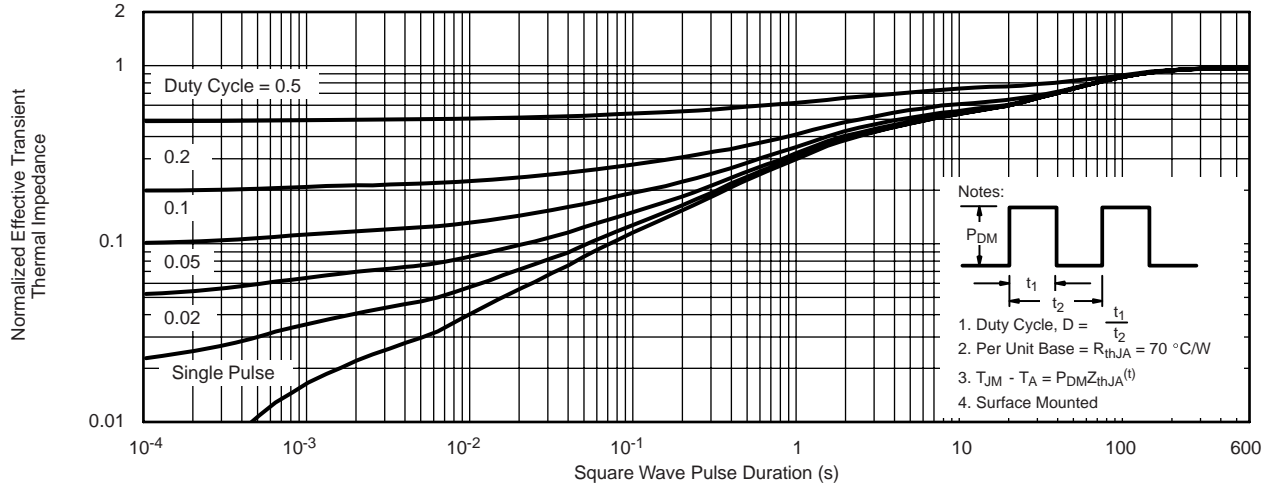

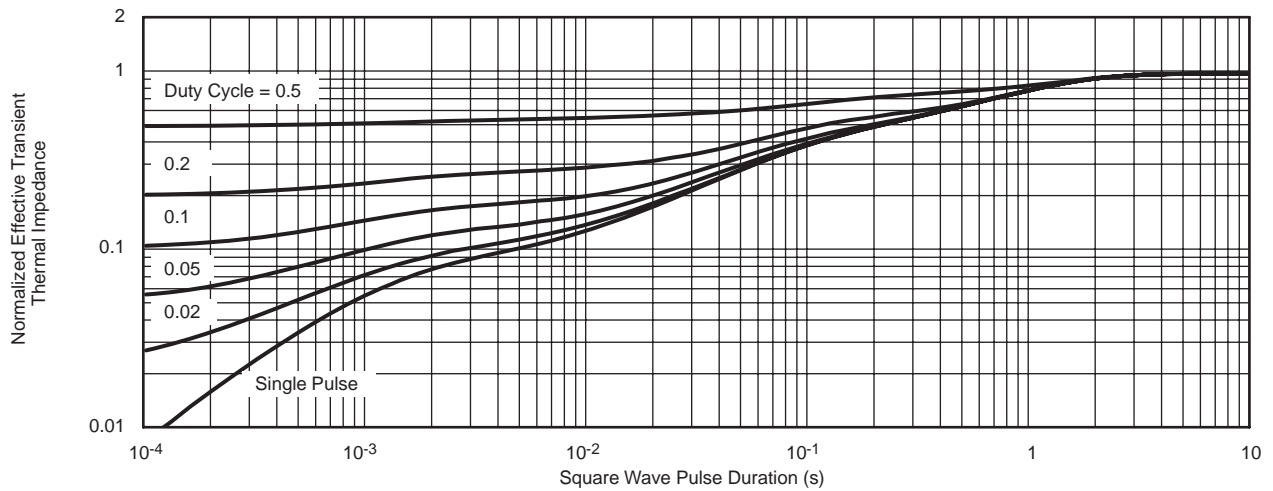

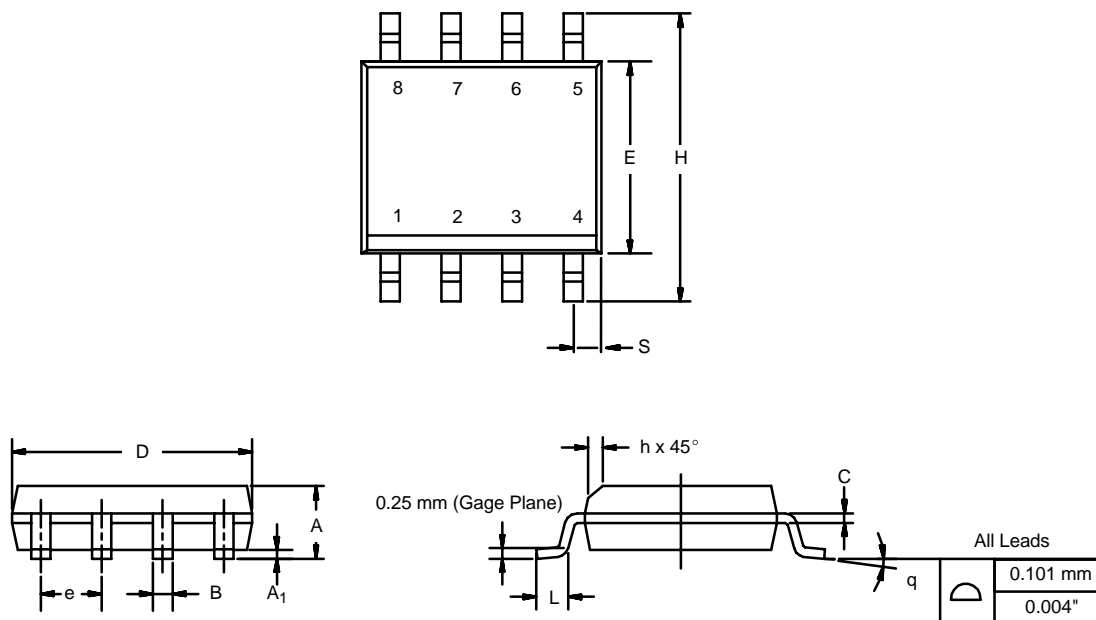


Normalized Thermal Transient Impedance, Junction-to-Ambient



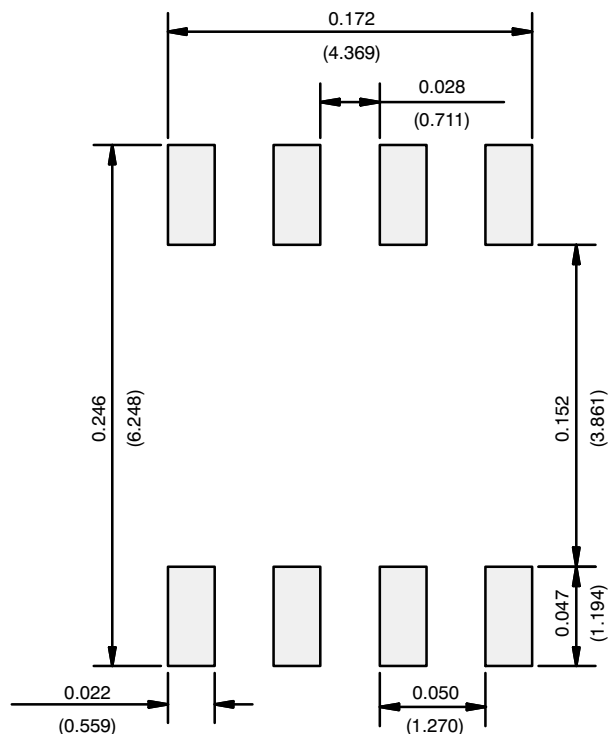
Normalized Thermal Transient Impedance, Junction-to-Foot
